However, due to low fuel consumptions, it is the employers practice to also accept 2800cc in place of 3000cc during implementation as part of Project Management.

	Kindly advise if it is possible to provide the drawings sent with addendum No. 2 with better quality, as there are some information that is not possible to read in the current drawings.	The bidder should have referred to specific drawings that needed replacement. However, all critical drawings were issued together with the Bidding Documents. Additional drawings provided with Clarification No.2 was mainly for ancillary works such as signage etc.
5.	Prospective bidders enquired as follows:	Prospective bidders are informed as follows:
	Enquired if a separate site visit could be arranged for a specific bidder.	As per ITB 7.4, Attendance was not mandatory or compulsory at either the Pre-Bid Meeting or the Site Visit. The Pre-Bid meeting and Site Visit has already been held on the scheduled date and cannot be rescheduled. However, bidders can undertake any additional Site Visit on their own.  Check also clarification No.2 on this issue.

	Bidding document, Part 3, Section VIII: Particular Conditions, item 13.83.3, The adjustment will only take effect starting from the 19th calendar month from the start of the contract in accordance with GCC Clause 1.1.3.2. The indices to be used will be those published by the South African Federation of Civil Engineering Contractors.	As similar question was raised and it was referred to the same Addendum No. 2.
