



Invitation for Bids (IFB)

TENDER NO. KBPO/WOR/1/24-25: TENDER FOR THE PROCUREMENT OF WORKS AND SERVICES UNDER DESIGN AND BUILD CONTRACT FOR CONSTRUCTION OF THE LANE EXPANSION AND REALIGNMENT OF THE ACCESS ROADS AND ADDITIONAL WORKS TO THE ONE STOP BORDER POSTS AT THE KAZUNGULA BORDER BETWEEN ZAMBIA AND BOTSWANA

The Kazungula Bridge Project Office (KBPO) has received financing from the Government of the Republic of Zambia and the Government of the Republic of Botswana through the 2024/2025 Budget for eligible payments towards the procurement of works and services under design and build contract for construction of the lane expansion and realignment of the access roads and additional works to the one stop border posts at the Kazungula border between Zambia and Botswana. The Kazungula Bridge Project Office now intends to apply part of the proceeds to payments under the Contract for the procurement of works and services under Design and Build Contract for construction of the lane expansion and realignment of the access roads and additional works to the One Stop Border Posts at the Kazungula. Bidding will be governed by the Procedures set out in the Public Procurement Act No.24 of 2021 and the Public Procurement Regulations No.37 of 2022 of Botswana.

The KBPO now invites sealed bids from eligible Bidders for the procurement of works and services under Design and Build Contract for construction of the lane expansion and realignment of the access roads and additional works to the One Stop Border Posts at the Kazungula border. The Public Procurement Regulatory Authority Standardized Conditions of Tender for Works shall apply to this procurement, for which all the applicable Tender Data is contained in the tender documents.

The scope of Works will include the following:

- a) Detailed Design and construction of lane expansion and realignment of the access roads
- b) Detailed Design and construction of addition and modification works on the OSBPs
- c) Development and implementation of EPB/EMP for the project.

The Period of Design and Build Contract is estimated to be 36 months (12 Months for Design and Build, 24 Months for Defects and Liability Period)

- a) 4 months Period for Detailed Design and Preparation of EPB/EMP report
- b) 8 months Construction Works
- c) The Defects Liability Period is 24 months

Bidding will be conducted through the Restricted International Bidding (RIB) procedures specified in the Public Procurement Act No.24 of 2021 of Botswana and the Public Procurement Regulations No.37 of 2022. The Procurement Method is: **Restricted International Bidding (Zambia and Botswana Citizen Registered Companies Only- 100 Percent Ownership).**

Eligible bidders may view the bidding document from the Administrator's Office at the Kazungula Bridge Project Office, Plot No., Kasane, Botswana.

A Site Visit is **Mandatory** and shall be held on **Thursday 26th September, 2024** and interested bidders are requested to meet at the Kazungula Bridge Project office DRTS Plot, Along A33 Road Kazungula at 09.00 hours. A Pre-bid meeting will be held immediately after the site visit. All participants are advised to follow all the Ministry of Health COVID-19 guidelines as they attend the Site Visit and Pre-Bid meeting.

All attendances shall adhere to the following:

Minimum qualification of Degree in Civil Engineering or Similar with valid Professional Body Registration & Practising Certificates and National Identity Cards as proof of ownership. All Company Representatives will be expected to wear Personal Protective Equipment (P.P.E). An individual or Representative will only represent one Company.
